TERMS & CONDITIONS

1. No tender will be accepted by post/telegraphically or by email and received after the date of opening.
2. Tenders will be sold on written application on the original official pad of contractor/firm from the office work of the undersigned up to 18th January, 2024 during office hours.
3. Application should accompany with attested copy of CNIC, Certificate showing class & category and field of specialization, having valid renewal of firm/contractor with Pakistan Engineering Council for current calendar year 2023-2024.
4. Tenders will only be issued to the owner of the firm or his authorized representative having legal power of attorney for this specific work. General power of attorney will not be acceptable.
5. Each tender must be accompanied with Bid Security in the shape of deposit at Call/Pay Order @ 5% or total cost of work (out of which 2% shall be accompanied with tender/offer as earnest money and remaining 3% after acceptance of tender/offer as security deposit) of the below estimated cost issued by any scheduled bank functioning at Rawalpindi/Islamabad in favour of Chairman Purchase Committee, DP&G, Survey of Pakistan, Rawalpindi at the time submission of Tender. Information regarding details of works, specifications and conditions can be seen in this office in any working day during office hours.
6. The firm/contractors should also furnish an attested copy of certificate showing registration with Income Tax department and partnership deed in case of partnership or affidavit declaring the contractor sole proprietor of the firm whichever is applicable.
